- A. We attempted to leave when the vehicle got stuck.

- A. It just the beach is sandy and I had pulled out on the sand and I was trying to come up there is a little knoll just before you pull onto the sand and my front tires got on the knoll and it would pull itself on over the knoll; it being in the sand.

Kim and Greg Norgard were at the Conoco station getting gas in Kim's (dad's) pickup the day before the homicide, on June 14, according to one of Greg's statements. Greg said he saw her there when she was getting gas and he was on his bicycle. Greg threw his bike in the back of her pickup and he got in with her to ride around. Barry may have seen them there when Jim Walkonis brought him home from out in the country. That was about the same time that evening.

Saturday, June 16, was the date Barry really looked in the fridge for a beer and was going to get something to eat but decided to just go to bed instead. Barb and I were in the kitchen when he came in to look in the fridge. He closed the refridgerator door and I asked him what he wanted. He said, "a beer." I asked him, "Since when do you come in and look for a beer?" He just laughed and said, "No, really I'm hungry but I'm tired too (from branding) so I'm just going to bed." It was about 6:30 P.M. then and he went to bed and got back up about 9:00 P.M. He ate when he got up and then he called Caleb Gourneau and told him to pick him up. He said he would start walking up by the school toward Exxon and Caleb could pick him up when he saw him. Then he left and came back later during the night.

In the other statement of Barry's that we read, Barry said it was a
white pickup parked there and Steve Shagunn was talking to Kim when he
was walking toward the Exxon.

All the kids around who knew Kim and knew Barry would tell you that Kim would never have let Barry in her pickup to ride around. They were not of the same social class, in fact, they really didn't care for each other.

Katherine Moe saw Kim alone at 12:40 A.M. and again at 1:00 A.M. and signed an affadavit to that effect.

Page 8 LOGICALLY: Would a person pick up a wrench off the floor of someone else's pickup in a fit of rage and automatically size up that tool? (Hypothetically-Hm, this is a 12" stainless steel chrome crescent wrench, okay, I'll use this.) The story that a crescent wrench and a tire tool were used to kill Kim was around town already by 9:00 A.M. when the stores opened up. The body did not even leave Poplar to Great Falls for the autopsy until shortly after 9:00 that morning.

There was a display in Beck's Sporting Goods window and in the Trader's State Bank display window after the homicide that included a crescent wrench and a tire tool along with pictures of Kim both alive and dead.

Barry had no scratches anywhere on his body the next day. About ten to twelve people saw him all day with his shirt off at branding at my parents ranch. The autopsy report revealed that Kim had no skin under her fingernails.

There were no strangulation marks on Kim's throat in the autopsy report and there would have been if he had tried to choke her in a fit of anger.

Page 9. Statem t from Barry Allen Beach, 1.

- I I dropped it when I got out of the pickup. I was trying to hurry up and get around there before she run off.
- Okay, then what happened? There was us blood found on drivers side for prokup, only on passengers side free A-10, Q.
- So, I had her up against the side of the pickup on the driver's side and I reached over in the back of the pickup and got a tire iron out of the back of the pickup and I started hitting her with that telling her I was going to kill her, calling her a bitch, and cussing her
- Okay, and then what happened?
- We started struggling and she got away from me and I had a hold to her coat. She run around to the other side of the pickup and I I tackled her on the other side of the pickup and I hit her a couple of more times.

She quit moving so I got up, and I stood up and I looked at her and took a couple of steps back and looked at her and then walked back over to where she was laying at and I reached down, checking for her pulse, and it was very weak one and then it stopped. And when it stopped, I stood up again and I said, oh, my God, what have I done. And I took a minute to think and I realized I had killed her.

And then what happened, Barry?

So I stopped to think what should I do. The first thing I could think of was to get rid of the evidence. So I threw the tire and the Crescer wrench in the river and I went I I started looking for a blanket or sor thing in the pickup and there a plastic bag in there - a garbage so And I got it and I tried to put the body in it. I drug it over to the edge of the bank of the river and I just pushed her on off over the edge of the bank and I turned around and I started looking and trying to think of what to do I was scared. see A-4 see B-6 think of what to do. I didn't really know what to do. I was scared.

And so I went and I got the keys out of the pickup and I threw the key in the river and picked her jacket up off of the ground and I threw it down by the body. And I took off running. I run towards my house the week and following sings. The bottom of the hill and I realized that I had blood all over me. So I went an the sweeter took my clothes off and wined as much of the blood off and I realized that I had blood all over me. the swader took my clothes off and wiped as much of the blood off as I could and the was weeked burned the clothes inside of a railroad box that was sitting there.

Also see the reports on Beleste Sheilds death 46 her clother were stacked by her body in the stone Sychion and I work ground when she me killed ... Page 9 Ted and Pam Nees both gave statements that the only tire tools in the pickup would have been <u>locked</u> in the tool box in the back of the pickup, and even under the sliding tray in there so they would have been very difficult to obtain.

There weren't any tire tool like marks on her arms in the autopsy report and there would have been if she was covering her head with her arms as he said.

In four divings; July, 1979; March, 1983; May, 1983; and June, 1983 there never was a crescent wrench, a tire tool, or pickup keys found.

In the other statement that Barb and I read, Barry said he threw the wrench and tiretool in the river about ten feet north of the body and threw them in after he threw her body in the river. He then said he went up on the train bridge and threw the pickup keys off the train bridge from about the middle of it towards the north. Then he said he walked on the railroad tracks, past the slew, until he came to a railroad car. He said he climbed in it, undressed, and set his clothes on fire with the garbage bag. Burlington Northern did not know of any fire in one of their boxcars during that time.

Barry is strong enough that if he had hit her that many times with the two weapons as he said. Kim would not have had enough strength to have run and to the point that he would even have to tackle her to overcome her.

Page 10 Whenever Burlington Northern ever had an arson attempt or anything burned in or around any of their boxcars they reported it to the local fire department. There was no such report in June of 1979 and Burlington Northern could not find such a report in their files.

Barry could not have washed up in the upstairs bathroom. There was no water supply upstairs. There had been a water leak in a very difficult place in the line and so the upstairs water supply had been shut off completely at that time. If he washed up down stairs he would have to wash in our bathroom in our bedroom and about four feet from my head. I am a very light sleeper. I would have also woke up if he tried to wash in the kitchen sink. It was next to our bedroom.

Barry was never missing any of his clothes. He had grown and worn out some of his clothes so he only had three pair of jeans. I would have definitely known if he was missing any clothes.

Barbara and I drove around and around looking for Barry that night. My brother was also looking for him. My brother had come to get Barry to go out in the country with him to be there early to round up the cattle for branding the next day. We left the house about 9:00 P M and returned about 10:15 P M. My brother came back about 11:00 and said he still could not find Barry so he was going home. Larry Rowe and Dorrance Steele had brought Barry home right after we left, but since Barry's car wasn't home none of us thought to look upstairs in bed for him. He was in bed asleep with his swim trunks still on from swimming the day before when I went upstairs to check his room for him at 4:45 A.M. when my husband and I got up that next morning. He was asleep with the bedroom door open, not closed. While we were looking for Barry that evening, we stopped several of his friends to ask if they had seen him but they all said they were looking for him, too. The police car was sitting downtown by Kelsey's Consignment Store watching traffic go by. I stopped and asked them if they had seen Barry. They said no, but if they did see him they would tell him to come home. Of all the people who were out that night no one ever gave a statement about Barry being out. In a small town of 2,000 people and only two main streets of three blocks long each, someone would have seen him. (Kenneth Grey Hawk saw Jim Walkonis, Billy McClammy, and Kim in Kim's pickup on June 14 turn around in front of his house and said it was Barry with Kim.)

Page 10 Cont. Barry described an outfit Pam and Kim both wore to school. One (blouse or jacket) belonged to Pam and the other belonged to Kim, but they wore them together occasionally. (Check Fam's January, 1983 statement). However, according to the autopsy report this was not what Kim was wearing. LOGICALLY: If she was wearing a blazer, why would she bring along the white sweater found at the scene, it was June and warm.

Jay Via said "placed her feet in" not Earry when referring to her body being in a garbage bag. Why did Calhoun ask head first or feet first a few lines further down? Was this an attempt at correction? If she was in the bag feet first with her head bleeding profusely, the bag could not account for no blood on the drag trail as the Prosecution tries to lead one to beleive. Barry recalls that Jay Via told him that there was a "silver-gray" color garbage bag found 1½ miles down the river from the death scene. Via said there was blood in it, and inferred that it was Kim's blood. We found no report of a garbage bag being found. If there was one found, how could it have been burned with the clothes?

Page 11. Statement from Torry Allen Beach, wm.

- A. Feet first.
- Q: And how much of the bag did you get around her?
- A. A pretty good bit of it.
- Q. Okay, when you drug her down to the river, how did you drag her?
- A. I had her I had the bag by the top of the bag and on the corners and I had her by the shoulders.

- A. I walked in the front door and straight up the stairs; the stairs are right there by the door.
- Q. To your knowledge, were they awake or asleep?
- A. They were asleep.
- Q. Do you know what time it was when you got home?
- A. No, sir:
- Q. Did you have a watch on?
- A. No, sir.
- Q. Did you have any difficulty getting from where you left the truck to your home?
- A. No, sir.
- Q. About how far is it from where you left the truck to your home?
- A. About an eighth of a mile. A Something like that.

Page 11 If Kim's body had been in a garbage bag, it would have torn off long before reaching the river. She weighed 116 pounds and she was dragged for 257 feet to the river over rough ground.

Calhoun said her legs were folded in the bag, not Barry. Earlier
Barry said the bag was up over her shoulders now he says under her armpits.

If there was a bag in either position, there would not have been the 19cm.

by 8cm. long scratches on her back and dirt inbedded in them from being dragged.

Our house had ten rooms, four upstairs and six downstairs with a basement. If he went right up the stairs from the door, how would he know if we were in bed, asleep, or even home? My husband did not come home until shortly after 2:00 A.M. (bar closing time.) If she was killed at about 1:30 A.M. as supposed by the autopsy report and the reports of the screams, Barry would have probably have gotten home at the about the same time.

Page 12 The weather report was: hail, turning to rain for that night. Hail

indicating that it was probably quite warm that early in the night. The moonlight was not very likely since there was probably a moderate to heavy cloud cover as the weather report would indicate and her screams were heard for a considerable distance from the scene at the houses up on the hill and at the house from where they were reported to the police.

For as much blood as there was in the pickup, Barry would have been very aware that there was blood in the pickup. He makes the blows inside the pickup sound very mild (even like one or two blows) for the amount of blood inside and the deep gouge marks on the dashboard, the steering wheel, and the ceiling, some even with hair in them.

Page 13. Statement from Barry Allen Beach, wm.

Page 13 Barry was definitely led into the statement about the purse. If this was a voluntary confession, he would have certainly known about the purse.

Kim's white sweater was neatly folded on the ground under the passenger side door and the red purse was neatly placed upon the sweater, indicating a deliberate act, not just a "dragging out" of the sweater and purse. In

the other statement we read, Barry said he picked the purse up off the seat

and threw it in the bushes beside the pickup. He also said it was a small

brown leather purse.

Page 14

Barry said earlier that he was wearing a flannel shirt. The only of flannel shirts he had at that time had the sleeves cut out of them at the shoulder seam to make them sleeveless. Two of them had worn out in the olbows and the other one was too short in the sleeves so were cut out. There were no sleeves to wipe the front fender with. Why would he wipe the drivers' side front fender? He indicated earlier that they were struggling behind the drivers' side door, far enough back for him to have supposedly reached in the box to pick up the tire tool.

What connection does him dragging her out of the pickup have with where he wiped the fingerprints? Also, why is he suddenly dragging her out of the pickup and she is struggling to stay in the pickup when he said earlier that she jumped out of the pickup to try to flee from him. (They are trying to account for the bloody palm print which was on the door moulding.) It did not match Barry nor did any of the other prints that were found on the pickup anywhere. If Barry would have been there he would have left prints several places on the pickup that could not have been wiped off without completely wiping both the inside and out as well as the door handles and pickup box.

THERE ARE MANY INCONSISTENCIES.

An interesting fact and maybe an impossibility:

If the actual time elapsed was only thirty eight minutes during the taking of the statement, there would be a question and response every five to six seconds. Hardly time to catch a breath for thirty eight minutes.

There is a report of some strands of hair that were found in the pickup seat. These were found to be fresh and were presumed to be dislodged from the person during the struggle in the pickup. However, they did NOT belong to either Kim or Barry.
